This geotechnical completion letter report is submitted in accordance with Section 12.4.1 of the Selwyn District Council Engineering Code of Practise.

1 Introduction

As part of the Fulton Hogan Land Development Limited (FHLD) Rosemerryn Subdivision Development located at Lincoln. As part of the development Aurecon has completed a geotechnical investigation and assessment of the wider site including the area that now identified as Stage 9 of Rosemerryn. This is detailed in the Aurecon geotechnical report "Geotechnical Investigation Report, Revision 2, Rosemerryn Farm Stages 7 to 15 Fulton Hogan Land Development Ltd", file 224464, dated 26 July 2012.

The report was issued following the publication of the Department of Building and Housing (now MBIE) guidelines, (dated November 2011) which define the new Technical Category zoning and the liquefaction induced deformation limits for each Technical Category. Overall the liquefaction risk at the site was assessed as being consistent with a Technical Category 2 (TC2) classification. As such no site specific liquefaction mitigation measures were required for the site development.

2 Liquefaction Hazard Assessment

The Ministry of Business Innovation & Employment (MBIE) guidelines define the Technical Category zoning and the liquefaction induced deformation limits for each Technical Category.

The categories and corresponding criteria are summarised as follows:

- **Technical Category 1 (TC1)** Future land damage from liquefaction is unlikely, and ground settlements are expected to be within normally accepted tolerances.
- **Technical Category 2 (TC2)** Minor to moderate land damage from liquefaction is possible in future large earthquakes.
- **Technical Category 3 (TC3)** Moderate to significant land damage from liquefaction is possible in future large earthquakes.

For the Canterbury region, the MBIE has released a new classification system for residential land on the flat in regard to liquefaction susceptibility. These are summarised below:

Table 1: Liquefaction Deformation Limits and House Foundation Implications

The liquefaction analysis for Stage 9 was based on the boreholes and CPT testing carried out as part of the geotechnical investigations for the larger subdivision. The geotechnical investigation information used to assess Stage 9 is part of a large group of geotechnical information and only the tests that are relevant for this stage have been assessed. Consideration was given to information and data from directly outside Stage 9 boundaries.

3 Technical Category Classification

Based upon our assessment and observed site performance we believe:

- Lots 1 to 30 fulfil the requirements of TC2 Classification.
- Lots 50, 51, 623, 624 and 814 are roading and reserve areas; therefore no Technical Category Classification is applicable for these lots.

A TC2 Classification effectively means that the MBIE believe that '*Minor to moderate land damage from liquefaction is possible in future significant earthquakes*'. House foundation design and site specific geotechnical investigations are required in accordance with the MBIE (2012) guideline documents '*Repairing and rebuilding houses affected by the Canterbury earthquakes*' released in December 2012.


